Additionally the S106 agreement will need to include an obligation to provide the site access, village gateway treatment, and footpath linking to the existing footpath and footpath improvements opposite Bletchingdon Road.

Comments:

A further technical note has been provided, TN03, which includes a Road Safety Audit Stage 1. I am satisfied that the mitigation proposed, including a vehicle activated sign (speed limit reminder) and a village gateway feature, is sufficient. I support the proposed speed limit changes, which would be subject to further, statutory consultation. These would provide additional mitigation to ensure compliance with the speed limit on the approach to the proposed access.

It is recommended that the condition for details of the access includes specification and position of the village gateway feature and VAS. The applicant should contact OCC for advice on this prior to submitting the details.

In addition to the obligations previously requested, a contribution is requested to allow OCC to supply and install the vehicle activated sign, which flashes up a reminder of the speed limit to approaching drivers. This amount includes a commuted sum for maintenance.

Additionally a contribution is required to allow OCC to consult on, and implement the change to speed limit, which would be outside the scope of the S278 works.

A further condition is required for details of the internal layout of the development.

No development shall commence unless and until full details of the means of access between the land and the highway, the footway connecting the development to the existing footway, and the village gateway feature and vehicle activated sign, including, position, layout, construction, drainage and vision splays, have been submitted to and approved in writing by the Local Planning Authority. The means of access, footway and village gateway feature shall be constructed in strict accordance with the approved details and shall be retained and maintained as such thereafter. Agreed vision splays shall be kept clear of obstructions higher than 0.6m at all times.

The roads turning area and car parking spaces shall be constructed in accordance with the approved details prior to the first occupation of the development.
