	station with integrated bus routes. Most fans currently drive to the Kassam whereas the club is committed to ensuring 90 per cent of journeys to the new stadium end on public transport. I currently drive to the Kassam by myself which can take up to 45 minutes depending on traffic, whereas at a new stadium I intend to travel to Oxford Parkway in a journey that can take as little as 10 minutes from my nearest train station, to which I can walk.	
	Another benefit is that 'The Triangle' is not currently open to the public and is unused scrubland, and the club taking on the lease will mean that a new public green space will be created at the north end of the site. This will have a positive impact on public wellbeing.	
	The club has also committed to improving and maintaining the sports facilities at Stratfield Brake in Kidlington as part of the move, representing a hugely beneficial commitment for the people of Kidlington and surrounding areas that use the facilities. The current facilities are in a poor state and are regularly waterlogged, and are in dire need of investment. With this initiative the club stands to actually be the real friend of Stratfield Brake and give the people of Kidlington the facilities they deserve to participate in activities that are good for their health, and of which they can be proud.
