Until November 2023 I lived in Begbroke. I now live in South Oxfordshire but have family in the area still and visit three to four times a week.

I am also an Oxford United fan and season ticket holder. I have been for 26 years. This club is everything to me. It is my community. It is my contact with local issues. I have made so many close friends, business associates and networking opportunities through attending match days and other Oxford United related events. This club is at the very heart of our community and our economy.

Firoz Kassam has nearly destroyed Oxford United once before. He will do so again. The Kassam stadium is a crumbling and poorly maintained blight on the image of Oxfordshire. Kassam will hold the county to ransom while he continues to have the power to do so.
