My siblings are all resident in Oxford and I have a boni•ed connection to this day with Oxford

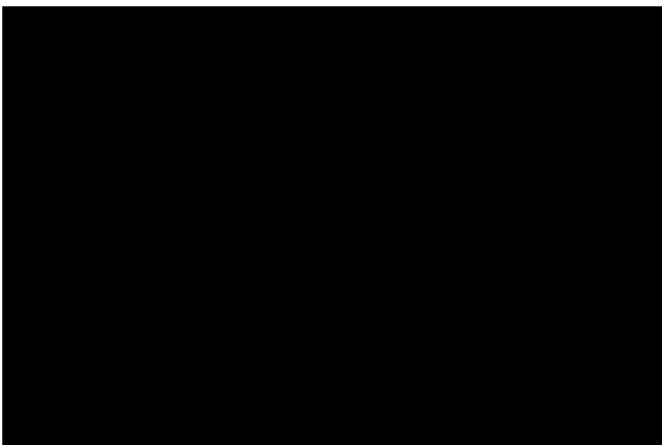
