Surely therefore the County Council must object to the planning application?</p> <p>This is going to have a huge effect on daily life and jobs and business. This put safty measures at increasing risk!</p> <p>Park Ride not enough spaces! Having lived near the current stadium and now living in kidlington. We are aware 1st hand of the traffic issue and onsite proposed parking is inadequate! we are very aware, this will cause cars been parked in streets like they do at blackbirds and residences paying a price to park in there streets.</p> <p>Environmental pollution and Impact on trees and wildlife:</p> <p>The notice pollution is awful having lived near the stadium, twice before we are fully aware of this! And the rubbish that is generated .
