Comments	I am objecting to the prop	oosal of the stadium for the following reasons:	
	1) Loss of amenity and accessibility to the local community - regular road closures and diversions will cause immeasurable disruption to local citizens and those passing through the north Oxford area who have a right to go about their business unimpeded. On principle alone this is unacceptable. No other sport or activity would be allowed to command this sort of privilege on such a regular basis. Anything considered for the site causing such disruption should NOT be allowed on this basis alone. Two specific examples: I know a mother of young children who will struggle to get to and from work shifts in central Oxford on the bus on match days (she doesn't have a car); in my case as a self-employed person I will be unable to see clients (they travel to my location in Kidlington) as the diversion and delay will make it too difficult for them to attend appointments, and also to difficult for us to travel to Oxford work locations on match days. This makes me anxious for the future living here in Kidlington and also very angry that it might be considered acceptable to interfere with my ability to earn a living and support my family. Why should Oxford United have the right to disrupt local lives and livelihoods in this way? What does an Oxford city football club have to do with Kidlington and why should this population have to suffer? The cost to the community is not proportionate to any possible benefit.
