Comments	The recent document released by Firoka , the current stadium owner and operator - clearly show their plans for the site including the stadium in 2026 and debunk the often lazy accusation that the club deliberately made it self homeless or can stay there long term with a new lease or licence or make an offer for the purchase of the site.OUFC have made a number of offers since the landlord separated the club from the stadium in 2006. The current stadium site and wider footprint is not for sale. The Kassam Stadium site, though, is badly designed, poorly situated and is not served adequately from a public transport point of view encouraging car use and the damage to the air quality that results. So the planning application submitted by OUFC - a 131 year old beloved institution with a proud history - offers the chance to secure a permanent home and provide world class facilities for both the club and the wider county.
