	I understand that there are some concerns about occasional traffic delays (or rerouting), but it's important to recognize that these will occur fewer than 30 times a year (23 home games, most at 3 p.m. on a Saturday and the remainder at 7:45 on a Tuesday, and a few cup games), and for only 45 minutes or an hour each. Moreover, if it's deemed necessary and appropriate, a footbridge will be built to alleviate traffic issues.		
	Residents are also concerned about potential noise and light from the stadium. Construction has been planned to keep both as much as possible within the stadium. In the past I lived less than a quarter of a mile from a stadium, and heard and saw almost nothing during games. People currently living in Blackbird Leys will no doubt say the same thing about noise and light emanating from the Kassam stadium.
