I am wrieng to object to the planned relocaeon of Oxford United's Stadium to the outskirts of Kidlington. I have been a resident in Kidlington Garden City for the past 30 years and though we have seen substaneal changes over this eme, this present proposal of a Stadium, will dwarf the negaeve impact of all other changes we have seen.

#### **Loss of Green Belt**

When we moved to Kidlington there was a disenct feel that we were not part of Oxford City, with the Golf Course, intervening elds and the now 'at-risk' triangle of trees being an established and recognised Green Belt that made Oxford City pleasantly compact and Kidlington a refuge and calm place outside of the City. Recent loss of the Golf Course and house building opposite is an unfortunate loss to this Green Belt and the loss of the triangle would make Oxford City and Kidlington a conurbaeon, degrading the living condieons for Kidlington residents and the surrounding villages.

Why the surrounding villages?, because the proposed stadium will adversely a •ect tra • c •ow with proposed road closures, and will impact a far wider community than just Kidlington. Though residents of Kidlington will be the most severely impacted.

## **Parking**

The proposal is to have 90% of people arriving by train, but this is highly unlikely to be the case. On the rare occasions that public events are held at Strath•eld Brake playing •elds, over•ow parking spills into Garden City increasing risk of accidents, making resident's own travelling and parking much more di • cult.

There is no way 90% of OU fans will arrive by train or bus, and over•ow parking will a•ect all residents in Kidlington and those in Garden City the worst. Not now on rare occasions, but every week. Even 10% of 15,000 fans will cause parking over•ow and a nightmare for local residents. You may be aware that currently a good number of train travellers prefer to park free in Garden City than to pay for a day's parking at the sta•on.

# **Public Safety**

I was on a train back from London at around 9pm on occasion last year and at High Wycombe a large group of OU fans got onto the train accompanied by two police constables, who were travelling with the

fan group to maintain public order. The group had been drinking and were foul mouthed and destroyed the peaceful journey back from London to Oxford. The police presence on the train was to ensure public safety in case the inebriated group should abuse or in midate other train passengers and to ensure no con ict between rival fans. They needed to step in on two occasions to calm the group, on the journey from High Wycombe to Oxford City Parkway.

One of OU's supporters of this present proposal at a public mee • ng in Kidlington Exeter Hall last year, said 'the majority of police public order ac • vity in Kidlington is around the pubs.' Note this is with no aggrava • ng tribal con • icts.

The proposed Stadium will provide alcohol on site and there clearly will be tribal rivalry. The OU supporter's comment that the majority of police ac • vity in Kidlington is around the pubs, does not bode well for rival soccer fans having access to alcohol.

Living in a quiet part of Kidlington with no pubs nearby, I am very concerned about the building of a football stadium and the increase in an •-social behaviour that generally accompanies this sport.

#### **Conclusion**

This is a poorly conceived plan, with insu • cient jus • ca • on to risk lives and the wellbeing of Kidlington and wider area village residents through impossible to plan for safety of the roads and general safety, to destroy and loose the remaining Green Belt / natural environment, and the considerable disrup • on to a popula • on that did not sign up for this.

The present Kassam Stadium has been around for many years, and is sell a challenge for local residents who were living locally before it was built and who sell complain of parking and travel problems on match days. However, those who now move into the area near the Kassam Stadium, do so in that knowledge. I strongly object to the cieng of a new OU Stadium on the triangle on the outskirts of Kidlington and strongly advocate for Oxford United to stay in the Kasam stadium where it is.
