RESIDENTIAL AREA PLANTING NOTES

GENERALLY: All plant materials to be planted at the density and quantities shown. All planting areas to be covered with 75mm depth of well composted mulch. Plant in groups of 2-4 of the same species with large shrubs to be planted at the back of the border.

BIOSECURITY: All plant stock to be sourced from a supplier certified to be pest and disease free and in accordance with Plant Passport / Animal and Plant Health Agency (APHA) and current DEFRA requirements. Support information / certification to be retained for a period of not less than 12 years and must be made available upon request.
