**Part discharge of Condition 2 pursuant to Reserved Matters Permission 23/01586/REM at Phase 2A,
Himley Village, Middleton Stoney Road, Bicester**

I write on behalf of Cala Homes (Cotswolds) Limited to part discharge Condition 2 (Facing and Roofing Materials) pursuant to Reserved Matters Permission 23/01586/REM at Phase 2A, Himley Village, Middleton Stoney Road, Bicester.

Condition 2 (Facing and Roofing Materials) states:

“Notwithstanding the approved Phase 2A Materials Plan ref: P22-3093-DE-101-J-06 dated 21st October 2024 (and excluding the Forterra Malvern Village Mix brick sample approved for use on Plots 1 to 8), no plot or building shall be constructed above slab level until full details of the facing and roofing materials for that plot or building have been submitted to and approved in writing by the Local Planning Authority. The development shall thereafter be completed in accordance with the approved details.”

Further to the Materials Plan that was approved through the Reserved Matters approval for Phase 2A, I submit the following plans in order to part discharge the requirements of this condition relating to the bricks, render, cladding and sub station roof only:

- Character Type 1 – Spine Road
 - o Red Brick 1 – Ibstock New Cavendish Stock



- Red Brick 2 – Ibstock Dorset Red Multi Stock
- Character Type 2 – Green Edge
 - Red Brick 2 – Ibstock Dorset Red Multi Stock
 - Coloured Board Cladding – James Hardie, Hardie Plank, Heathered Moss in Cedar Finish
- Character Type 3 – Core Housing South
 - Red Brick 2 – Ibstock Dorset Red Multi Stock
 - Red Brick 3 – Ibstock Leicester Red Stock
 - Orange Brick – Forterra Autumn Glow
- Character Type 4 – Central Green
 - Light Red Brick - Forterra Malvern Village Mix
 - Render – Monocouche Render Systems in Heritage White
- Sub Station
 - Red Brick 1 – Ibstock New Cavendish Stock
 - Roof – GRP Slate Grey RAL 7015
- Supporting Photos of Bricks, Render and Cladding
