The plate in the apex of the gable above the clerestory window in the original plans supports the roof supporting steel. The triangular clerestory window is positioned very close (250mm) to the steel supporting plate.

The greater volume of blockwork (faced by stone) surrounding the proposed rectangular window and lintels above provide greater support for the roof steel. The top of the proposed smaller rectangular window is 480mm below the plate for the steel.

The rectangular window in retrospect looks out of place while the rectangular windows is more in keeping with buildings in the conservation area.
