Conditions:

- That before the sites in Longford Park 'Bankside Sports Pavilion' is first occupied the
 whole of the estate roads and footpaths of that phase, shall be laid out, constructed, lit
 and drained and if required temporary or permanent traffic calming to the Oxfordshire
 County Council's Specifications.
- 2. That, before the site is first occupied in Longford Park 'Bankside Sports Pavilion', the proposed vehicular accesses, driveways and turning areas that serve those dwellings shall be constructed, laid out, surfaced and drained in accordance with the specification details to be submitted to and approved in writing by the Local Planning Authority prior to the commencement of development.
- 3. Before the site is first occupied in Longford Park 'Bankside Sports Pavilion' the parking and manoeuvring areas shall be provided in accordance with the plan (to be approved) hereby approved and shall be constructed, laid out, surfaced, drained and completed, and shall be retained unobstructed except for the parking and manoeuvring of vehicles at all times.
- 4. Prior to the commencement of the development hereby approved, full details of the access vision splays, including layout and construction shall be submitted to and approved in writing by the Local Planning Authority. Thereafter, and prior to the first occupation of Longford Park 'Bankside Sports Pavilion' the vision splays shall be

constructed in accordance with the approved details and the land and vegetation within the vision splays shall not be raised or allowed to grow above a maximum height of 0.6m above carriageway level.

- 5. No development shall commence on site for the development until a Construction Traffic Management Plan providing full details of the phasing of the development has been submitted to and approved in writing by the Local Planning Authority (in consultation with the Local Highway Authority) prior to the commencement of development. This plan is to include wheel washing facilities, a restriction on construction & delivery traffic during construction and a route to the development site. The approved Plan shall be implemented in full during the entire construction phase and shall reflect the measures included in the Construction Method Statement received.
- 6. The surfacing to the parking area should be permeable paving and a condition should be applied to any permission to ensure that prior to occupation the parking area is constructed SUDS compliant.

Reason to accord with Sustainable Drainage Systems (SUDS)

Detailed Comments:

I have identified a number of areas below that require some amendments:

- No Cycle parking has been demonstrated on the supplied plans; this will need to comply with standards in terms of number of spaces, covered/secure, located as close to the main entrance to the building as possible and use 'Sheffield' type cycle stands.
- The Highway Authority has concerns regarding the proposed coach parking arrangement and there is likely access/egress issues – vehicle tracking will need to be supplied
- No refuse storage has been demonstrated, furthermore refuse vehicle tracking will need to be submitted

Summary

Taking the above into account, there are a number of design issues that require further consideration and information, which will need to be resolved before support can be given to this planning application. Therefore as submitted, I object to this application until the above issues are resolved to the Local Planning Authority and Local Highway Authority's satisfaction.

However, if the Local Planning Authority is minded to approve the submitted application, I would recommend the conditions quoted above are imposed.
