1. APPLICATION SITE AND DESCRIPTION OF APPROVED DEVELOPMENT

1.1. The application site relates to the spine road that has been constructed through the residential development known as Longford Park, a large residential scheme with country park, primary school, open space and leisure facilities. The spine road links Oxford Road to Bankside, with a loop section at the local centre and school.

2. CONDITIONS PROPOSED TO BE DISCHARGED

- 2.1. The conditions which this application seeks to confirm details are acceptable for are summarised below:
 - Condition 3 Spine Road Details
 - Condition 4 Landscaping Scheme
 - Condition 6 Tree Pits
 - Condition 9 Gate Enclosure to Canal Lane

3. RELEVANT PLANNING HISTORY

3.1. The following planning history is considered relevant to the current proposal:

4. RESPONSE TO CONSULTATION

4.1. Consultation letters were sent to OCC Highways, CDC Landscaping and CDC Arboriculture; no responses were received.

5. APPRAISAL

5.1. Since receipt of this application, the spine road has been constructed and is now adopted and in use. Therefore, whilst each of these conditions were precommencement conditions requiring the submission of the details and their subsequent approval prior to any construction works being undertaken, the development has now been constructed. This is regrettable and means that it is now very difficult for the Local Planning Authority to seek changes to the submitted details; it would only be justified to refuse the details if they were clearly unacceptable to the point that enforcement action would be justified.

5.2. Consultation was carried out in respect of the proposals, but no responses were received. The road has subsequently been completed and adopted and is in use. Therefore, and in the absence of any evidence or reasoning to the contrary, the works as constructed are considered acceptable. A photographic record of the completed works has been taken.
