




- E4 PARK STREETS GENERALLY CORE RESIDENTIAL AREAS CA7-CA8






Location of Edges Types & Key Corners



The Planning Application shows:

- E4 a consistent building line comprising a mix of detached, semi-detached and terraced form. Min 1-4m setback from back edge of kerb.
- ✓ E6 symmetrical balanced form & consistent building lines comprising detached dwellings. Min 2-6m setback from back edge of kerb.
 - E6 also includes some semi-detached dwellings.
- ✓ E7 an irregular building frontage formed by front gardens / parking zones.
