2) 4/6 Cheshire Rd	Weeping willow	Located in rear gardens, x2 weeping Willow previously pollarded, carefully sectional dismantle to ground level both trees.
3) 16 Portnal drive N	Cherry	Located in rear garden, Crown lift to provide a 3m ground clearance.
4) 21 Portnal Drive S	Cherry	Located in rear garden (Tag 02375) Impeding fence, remove to ground level.
