T164 - Beech - Crown lift/prune western canopy of all overhanging branches necessary to maintain at least a 2.5-3m clearance of building 103 to ensure there is no direct contact between the canopy and the roof of building 103. Remove vertically kinked branch back to main horizontal branch at far western canopy.

The current canopy overhang comes into direct contact with the roof of building 103. Following the repair/reconstruction of the roof to enable the change of use as per application/01545/F, pruning/lifting overhanging branches is required to prevent direct contact and damage to the new roof.

Some of the branches in close proximity to the roof comprise deadwood and some with limited leaf bearing structure. A ground level inspection suggests that to achieve a clearance of at least 2.5-3m (and removed deadwood/poor quality branches) the first three branches on the western side of the eastern stem would need to be removed and five branches on the western side of the western stem. Branches expected to be pruned/removed are shown in the accompanying photographs.
