1004 - Whitebeam - Fell to ground level due to pronounced crown die-back, major deadwood & terminal decline.
1006/1295 - Laburnum - Fell to ground level due to extensive wound decay.
1032 - Norway Maple - Fell to ground level due to necrotic bark & structural wound.
1038 - Norway Maple - Fell to ground level due to crown decline.
1098 - Norway Maple - Fell to ground level due to stem cavities near busy road junction.
1147 - Silver Birch - Fell to ground level due to pronounced crown die-back, terminal decline and fungus.
1253 - Cherry - Fell to ground level due numerous cavities and decay.
1264 - Sycamore - Remove dead and dying branches.
1296 - Sycamore - Fell to ground level due to decay.
1346 - Hybrid Poplar - Fell to ground level due to crown die-back and major deadwood.
1378 - Sycamore - Fell to ground level due to crown die-back and major deadwood.
1415 - Hybrid Black Poplar- Fell to ground level due to inherent risk of branch failure and proximity to buildings. Causing damage to pathway to building and now a health and safety hazard.
1431 - Whitebeam - Fell to ground level due to structural cavities overhanging parking area.
1523 - Whitebeam - Remove defective stems to 2.5m above ground.
