Remove lowest west facing branch

Reduce west facing lateral branches to provide a clearance of 2 meters from property

Remove major deadwood

2. Beech x3 - Section fell trees

3. Cherry - Section fell tree

Reason - Owing to the space constrains of the location the removal of these suppressed specimens, east to west central area of garden, will allow adjacent trees to improve their structure and continue to mature.

The space created will also help initially to increase the air flow and light penetration to the garden.
