		- Character Type 1 amendments - Window sizes are now a more elegant proportion. Reduced in width by ½ brick. Proposed lower string course to sit at ground floor window head level rather than first floor sill level, resulting in improved balance of the elevations composition. Window heads and sills now proposed in stone rather than brick. Gable clipped verge detail proposed in stone/stone effect rather than brick. Entrance door and canopy updated to be more contemporary.

2102	2102	 Character Type 3 amendments - Window sizes are now a more elegant proportion. Reduced in width by ½ brick. Proposed to remove the blanking panel and used full glazing. Rear elevation upper floor windows proposed to be 1125mm sill height rather than full height to avoid future technical concerns with condensation. Timber split to front, rear and side elevations proposed to be centred. Addition of Character Type 1 beckstone and render elevation to apply to plots noted on the drawing. Enriched elevation updates to roof form to avoid future technical concerns regarding water penetration and maintenance. Recessed alternating brick coursing added to base front, rear and side elevations and addition of precast window surrounds to add visual interest and enrichment. Enriched Timber elevation included to meet the requirements of the additional condition to the June 2017 approval. Amendments to Character Type 1 as noted above under drawings 2100 & 2101 Addition of Character Type 1 beckstone and render elevation to apply to plots noted on the drawing.

Associated plots are now proposed as Character Type 3, timber and render, sawtooth roof. - Proposed new enriched elevation treatment to plots 69-71 and 139-142. Proposal is for becktone facing material. This is to pick up the design challenge that these enriched types are required to have a linear roof form. Further this treatment helps to clearly define the entrance to the development. - Enriched Timber elevation included to meet the requirements of the additional condition to the June 2017 approval. - General amendments to internal layouts.
