REASONS

T1 (RED) Create more space for Oaks behind. T1 is in competition with larger oak trees behind and has a significant lean towards main road.

T2 (BLUE) Overcrowding. Fell for the purpose of creating more space for the other tree in the group TPO to develop.

T3-T4 (YELLOW) The two trees have grown together and are situated in close proximity to the main road. The most southern tree has a codominant stem compromising its structural integrity, the most northern tree has a large historical wound at the base of the stem 40cm-50cm.

NOTE; The removal of these trees was granted in 1996 application no; 96/00050/TPO (TPO12/1994)
