Tree has been inspected by Mr. M. Steele (Bicester Tree Services) who states that:
The Norway maple has unions in the main stems and major scaffold branches at 2-4 meters

He recommends that we have the tree felled and replaced with a Betula pendula 4.5-5m tall.

Apart from Mr Stelle's expert opinion that the tree should be removed, on a practical point for the residents, the tree is massive ~~and~~ with lots of leaves. In the autumn the leaves are blocking up gutters + drains to the point that residents at 45 + 47 Skimmingsh are battling damp inside their upstairs rooms due to water back flowing into the brick work due to gutters being continually blocked.
