The current approved drawings show the roof above the original house being converted into a master bedroom suite. The approved drawings showed a staircase in the new extension, however, the proposals do not meet building regulations and so the stairs need to be relocated. The head height in the existing loft is also limited and so access into it from a new staircase is not possible.

In order to enable the roof space to be made usable we are proposing raising the height of the existing roof. Along with making the roof space usable it will enable the roof line of the building to be stepped which will sit well on the street scene.
