The threshold of normal hearing is in the region of 0 dB and 140 dB is the threshold of pain. A change of 1 dB is only perceptible under controlled conditions.
dB (A), L <sub>Ax</sub>	(noise quality) 1. Decibels measured on a sound level meter incorporating a frequency weighting (A weighting) which differentiates between sounds of different frequency (pitch) in a similar way to the human ear. Measurements in dB(A) broadly agree with people’s assessment of loudness. A change of 3 dB(A) is the minimum perceptible under normal conditions, and a change of 10 dB(A) corresponds roughly to halving or doubling the loudness of a sound. The background noise in a living room may be about 30 dB(A); normal conversation about 60 dB(A) at 1 metre; heavy road traffic about 80 dB(A) at 10 metres; the level near a pneumatic drill about 100 dB(A).

Users are able to calculate road vehicle pollutant emission rates for Nitrogen Oxides (usually Nitric Oxide), Particulate Matter and hydrocarbons for a specified year, road type, vehicle speed and vehicle fleet composition. CO2 emission rates can also be calculated for petrol and diesel fuelled vehicles.
Employment Density Guide	A guide which provides advice to practitioners involved in regeneration and economic development projects on employment densities associated with different types of property use, published by the Homes and Communities Agency
