CONTENTS

For the purpose of the Supplementary Environmental Information (March SEI) all figures which have been updated from the submitted Environmental Statement (2018) have been re-numbered so that they have an 'a' within their numbering. For example, Figure 2.1 would become 2.1a. If the figure has not altered from the 2018 Environmental Statement its numbering has remained the same and a copy of the un-altered figure was included within the March SEI for completeness. There are very few amended figures for this second SEI (June 2020). Those which have needed to be updated have had a 'b' added to within their numbering. Those that are not required to be updated have retained their referencing as laid out in the SEI from March 2020 or the 2018 ES.
