I have been given your contact details from a lady in our village, Kirtlington, who is helping to fight the residents' battle against the traffic.

I have only just been made aware that there is going to be huge development in Upper Heyford and I am horrified to think of what the increased traffic is going to do to the road going through our village. As it is, our road is constantly full of traffic, thanks to it being the main route between Bicester and Whitney and due to the fact that Smith's have their base in Enslow and their easiest route is through our village. I live just at the entrance of the village and the traffic is going very fast at this point whether it is coming into the village or going out. The speed the trucks and cars go over the rather ineffectual speed humps that we have, shakes the furniture in my house! I also have noticed that the walls of the houses along the 4095, especially The Dashwood Arms, a listed property right at the corner, are black from all the pollution going through the village.

I have heard that some of the villages along the 4095 route have been granted funds to help with traffic calming and I am sincerely hoping that our village will also be granted funds for that. We have a school, listed buildings and are a village – we cannot take any more traffic through the village, especially big lorries and speeding cars.

Please consider our request – the villagers who live along the 4095, like me, are feeling very disturbed about the traffic situation and cannot bear the thought that we can expect even heavier traffic in the future.
