Dear Mr Lewis

I write as a resident of Kirtlington, concerned to hear that the developer is not prepared to offer any traffic calming funds to our village.

We live on the edge of South Green, between two bends in the A4095 road, which can be positively dangerous at rush hours and likely to be so for most of the day with the increased traffic from the development. Children going to and fro to our primary school and elderly people are particularly at risk.

I would propose -:

- A 20mph speed limit through the village
- Signage at the North Green area coming into the village and by the Oxford Arms coming from Oxford to slow down for these bends

- A maximum of three cars allowed to park by the roadside, (see my recent photo) to avoid the virtual contraflow system we suffer at present
- A maximum allowable vehicle weight which would exclude construction traffic

I cannot know how the funding can be achieved, but I hope that you will consider this as a priority.
