Having just chatted to Sam, she kindly said that I could email across my objection for this project's BUSGATE. (I have been in hospital with a stroke and just home from hospital so missed the deadline as a result- I was banned from a computer in hospital!).

Please could my objection be added to the page:

As the planners are aware, North Aston is a small, rural village and many of the residents are closely involved in either the farming or North Aston Organics.

The current Busgate proposal would have significantly damaging effects on the village for the following reasons:

. Having read the document, I do not feel there is any rationale or thought been given to diverting such volumes of traffic from one part of the valley to another. Simply moving a problem does not address a problem.

. It is well-documented by residents, CDCouncillors, our MP, etc about the levels and dangers of traffic on the road through the village already. Many instances already of danger to life, including children, and not always associated with speeding...there is a poor visibility issue as cars come up through the narrow entrance from Somerton. During lockdown I walked my dog on the lead a great deal down to Somerton. There were times that can only be described as terrifying. The thought of yet more traffic is such a concern.

. I gather we would receive £50k as a village - we have all been informed that this is not sufficient for traffic calming measures to make a difference. So not a reason for mitigation.

I respectfully ask the planning department to think again about this. I appreciate the additional traffic has to go somewhere, but not at the expense to danger of life in North Aston.
