Re the above application.

I am a resident of Chesterton with a house fronting onto the A4095 opposite the Chesterton Hotel. As I understand it the plan would divert the heavy goods traffic from the Middle Stoney cross road around three sides of a rectangle through Chesterton. I believe the concern is the turn at the cross roads. This seems to me to be diverting a problem which is traffic light controlled to a more dangerous and in practical route. There is an excellent give way just outside our property that slows traffic but with an increase in standing traffic. This plan will increase emission and noise pollution in a residential area. Has the emission consequences on health been quantified and assessed?

Most critically, the A 4095 turn into Chesterton is blind and difficult even for cars. Vehicles regularly cross the centre line (if there was one painted!) to navigate this. Lorries in particular. At the apex of the corner is an entering road with limited visibility their left.

We have just had a new estate at that junction with an increased traffic flow. Relocation of the playing fields again will increase traffic flow at the apex of the corner. Furthermore the Great Wolf planning application has been appealed and hence this major impact on traffic has not been put to bed yet.

The existing road to Bicester has been recently upgraded at the junction to Vendee Drive. This road from Middleton Stoney is wide with minimal commercial and few residential properties.

So in summary

I am concerned that the plan will just move a traffic light controlled problem to a dangerous and uncontrolled corner along with the above issues.
