Hi Rebekah,

As per our earlier discussion regarding the above conditions, I have attached the necessary supporting information to support the comments below.

Condition 16:- Biodiversity, we are proposing alternative locations to plots that are still in our control and have not been sold/occupied.

Please refer to the documents annotated as “Key” and “Extract of Phase 3” for our proposed location on the bat and bird boxes. For your reference and comparison, I have also attached the planning approved bat and bird box location drawing.

- **Swchwegler bat bricks 3 No** – currently shown on plots 951, apart. block 955-960 and 961-966 proposed to move to plots 900, 905 & 914
- **Swchwegler Sparrow Terrace 3no.** – they stay as per the original proposal.
- Swchwegler Avianex 3No. – currently shown on garages to plots 967, 993 & 1015 proposed to move to garage for plots 904, 907 & 910
- **Swchwegler Swift box 3no.** – currently shown on plots 927, 990 & 993 proposed to move to plots 906, 913 & 914.

Condition 17:- As discussed I have attached bin and cycle store building for the apartment block plots 955-960 and 961-966 as supporting details / information to discharge the condition.

I look forward to your earliest acceptance / comments of the attached, so that I can formally submit the information to tie in with the current condition discharge application for Con 2 & 9.
