<b>Comments</b>	<input type="text" value="As a resident of Hobby Road, down which it is proposed that the vast and continuous amount of construction and HGV traffic for the new development will be directed, I cannot object to this proposal strongly enough. I object on the following bases; 1. It is absurd that a quiet residential road, with barely enough space for two cars to pass side-by-side could accomodate the constant stream of lorries, vans, HGVs, and other construction vehicles safely, without damage to resident's cars, the road surface or our houses. 2. Children who live in the area, such as my own, use the road for going to school and for local amenities. Their safety would be substantially compromised by the construction traffic coming down this otherwise quiet road. 3. Given the scarcity of parking for residents' cars they are forced to park on the road side. This drastically constricts the passageway on the road such that cars cannot pass each other, and are forced to give way and wait their turn. There simply wouldn't be enough space for construction vehicles. 4. The road surface would not withstand prolonged HGV use. This would be to huge detriment to residents here and very costly for the authorities to replace. 5. The disruption to those of us who work from home would be unbearable. The noise of having HGVs, site vehicles and other construction traffic accessing the new site would be extremely intrusive and detrimental to working conditions. 6. The increased locall pollution of air caused by the construction traffic alone should be enough for this ridiculous proposal to be rejected. Airborne particulate matter would increase, as well as the noxious fumes from the vehicle engines; all concentrated around this closely packed residential area. I would urge you to reject this proposal and impose on the developers to create a dedicated access to the new site, not ruin the lives of residents of a quiet street. Yours kindly, Ben Blackburn"/>
