# Dear Rob,

I have enough detail to assess the RM applications but regarding the condition discharge application we will need further detail.

In my previous comments I asked for the following;

- A compliance report to demonstrate how the scheme complies with the overall drainage strategy for the site and current local and national surface water drainage standards;
- Full microdrainage calculations for all events up to and including the 1 in 100 year plus climate change;
- Full infiltration tests to BRE 365 at the location of each infiltration feature;
- Details of how existing surface water flow routes will be maintained and managed post development;
- A Flood Exceedance Conveyance Plan;
- Detailed design drainage layout drawings of the SuDS proposals including cross section details;
- Detailed maintenance management plan in accordance with Section 32 of CIRIA C753 including maintenance schedules for each drainage element; and
- Details of how water quality will be maintained during construction.

I will provide detailed comments on the RM applications in due course. From a drainage point of view I cannot see the introduction of further swales being an issue but this may cause an issue for other consultees?
